Motion to approve minutes - Lauren Miranda- and seconded by Jennifer Omerovic Keli Keyes introduced Mr. Logan Lowery

Lowery Highlights: legislative updates and his primary role as a lobbyist, provided a 2024 legislative platform (state funding, state policy and federal funds), 83 new school board updates, cap on ESE for family empowerment to change, this year's focus is deregulation of public schools – level the playing field for public, charter, and private schools, state funding for teacher's salaries won't change much, ESE service costs can sometimes come from the BSA (Base Student Allocation), no state money to build new schools – mostly through local dollars, PICO funding goes to charter schools now, high property insurance costs for less coverage, fee

waivers for 1st attempt for certification tests, underfunded nationally, promoting resources to help with the concepts of funds without restraints, ideally more from the state – we are only 22% of the state's budget now

Principal's Report

Last year's survey suggested to get better at communication.

Puma Power Course a huge success – all could participate regardless of fundraising, volunteers were amazing, most of the money going back to the school for more computers/carts and resource teachers to get \$ towards needs, teacher grants

Parent asked if percentage of funds allocated equally, long term plan for housing students in portables against the elements, playground covering – more opportunities

Mr. Morgan replied that we will keep the kids safe in the cafeteria if the elements keep them from waiting outside the portable classrooms, can add those ideas for next year's goals Other parent weighed in (Steven Lopez) – likes the ideas of covered areas, especially with high heat advisory days (Mr. Morgan – weigh out the costs, added water cooler stations)

Amy Bishop – maybe use some more \$ for Ipads for our ELL students

Morgan – planning on adding large fans

Parent – (Holloman) asked about P.E. times – maybe adjust when hot days?, Morgan – use of fan Parent – (Norori) pest control? Morgan – yes, we have our regular maintenance, looking into outside pest control and costs – getting quotes, right now Mr. Coarsey helping out as of right now
