Principal's Report

Mr. Morgan shared that there has been construction going on in Trailmark behind the school and the barrier of trees has been removed. Working with district to create another barrier for safety.

Job openings will be posted soon for next school year, if anyone knows anyone looking for a position next year.

Guest Speaker: (Mike Strausbaugh-Safety and Security Specialist)

Mr. Strausbaugh shared the District Safety and Security update. All schools in Florida submit a Florida Safe School Assessment Tool (FSSAT) to FDOE. He also reviewed the Safe-School officers that are represented throughout the school district. This program is underfunded almost 2 million dollars, which comes out of the district budget. He also reviewed the School Environmental Safety Incident Reporting (SESIR). Each school year all students and staff must participate in an active assailant/hostile intruder drills/training. He mentioned that Picolata Crossing had a compliance check about three weeks ago and received a perfect score. All schools have a Threat Management Team that meet monthly or as needed and all threats are archived and reviewed using Navigate360. Anyone can also report suspicious activity online using FortifyFL app. At least 80% of district employees must be trained with Youth Mental Health First Aid. He also reviewed Centegix, which allows any employee to call a lock down if they see something suspicious.

Ms. Camilo asked if there was a program to assess teachers' mental health, like the Youth Mental Health First Aid assess student's mental health. Mr. Morgan reviewed that we have a Sunshine Committee that helps support staff during times of loss, etc. and also counseling resources can be provided to staff as needed.

Ms. Kellerman asked about how students with disabilities are assessed for mental health first aid. Mr. Strausbaugh and Mr. Morgan shared that there is a team of people who are trained to work with students with disabilities and how to handle these situations.
