### **SAC News**

#### Review SAC Survey

Keli Keyes shared the results from this years parent survey and went through each question, as well as read each typed response.

195 total respondents

Mr. Morgan then addressed the typed responses. He shared that these written responses represent .9%.

He addressed response #4-Clay County vs. St. Johns County. SJCSD is higher than Clay County in all every single subject. Acceleration, Graduation and College and Career Acceleration were the only ones SJCSD were lower in.

He also addressed #7, communication. All dismissal changes should go to the front office and that is stated on the front of the school's website.

#8-SAC Request Form addresses this-the school is currently trying to organize new afterschool programs.

Ms. Norori said that she would be interested in helping sponsor an economics group, where students are taught budgeting.

Mr. Camilo said he would like to see a chorus program.

#10-Celebrating Academics, Behavior and Character Counts-incentives encourage students to work hard and recognize them for doing so. He also shared how much time per grade level students are using Dreambox and Lexia each day.

#14-Safety of Portables-new fence has been put up with a fence with privacy slats at the perimeter of the back of the school property. No plan currently to put up a wall where current fence near portables is.

#16-School grade has gone up each year over the past 3 years. There is also computer lab typing practice built into the resource schedule.

Ms. Norori asked if he could touch on response #9 and where they spoke about the safety of their child in the classroom. Mr. Morgan shared that are some behaviors this year that may be what they are speaking about. Ms. Norori also asked if the school could follow up with this specific respondent to address this concern.

Ms. Hollomon asked about the communication piece and if there has been any thought about using a consistent approach to communication with parents and also if there is still an open

house/curriculum night. Mr. Morgan shared that all parents are offered a parent/teacher conference during the first quarter of school. There is also a virtual curriculum chat.
